

GIFTS OF GRATITUDE RULES

THE “GIFTS OF GRATITUDE” CONTEST (THE “**CONTEST**”) IS INTENDED TO BE CONDUCTED IN THE PROVINCE OF ONTARIO ONLY AND SHALL BE CONSTRUED AND EVALUATED ACCORDING TO APPLICABLE CANADIAN LAW. NO PURCHASE IS NECESSARY. PARTICIPANTS MUST BE OF THE AGE OF MAJORITY IN THE PROVINCE OF ONTARIO OR OLDER AT THE TIME OF ENTRY. VOID IN WHOLE OR IN PART WHERE PROHIBITED BY LAW. ENTRY IN THIS CONTEST CONSTITUTES ACCEPTANCE OF THESE CONTEST RULES (THE “**CONTEST RULES**”).

1. ELIGIBILITY. To be eligible for this Contest, an individual must:

- (a) be a legal resident of the province of Ontario;
- (b) be of the age of majority or older at the time of entry; and
- (c) Nominees (defined below) of entrants must: i) be a legal resident of the province of Ontario; ii) be of the age of majority or older at the time of entry, (iii) must reside in the City or County of Peterborough, Curve Lake First Nation or Hiawatha First Nation; and iv) have provided consent to enter the Contest.

2. CONTEST PERIOD. The Contest begins at 12:00 a.m. Eastern Time (“**ET**”) on April 26, 2021 and ends at 11:59 p.m. ET on May 31, 2021 (the “**Contest Period**”) after which time the Contest will be closed and no other entries shall be accepted.

3. HOW TO ENTER.

- (a) There is no purchase necessary to enter the Contest. Enter using the method of entry outlined below. No entries will be accepted by any other means.
 - (i) To enter online, complete and submit the entry form located at <https://thewolf.ca/contests/> and <https://1005freshradio.ca/contests/> (the “**Contest Websites**”) including the name, address and occupation of a frontline or essential worker you know (the “**Nominee**”) on the entry form and selecting which prize

draw you would like your Nominee to win.

- (b) Limit of one (1) entry per Nominee per e-mail address per 24-hour period. In the case of multiple entries, only the first eligible entry will be considered.
- (c) All entries become the sole property of the Sponsors and will not be returned for any reason. Entries must be received no later than the end of the Contest Period. Entries will be declared invalid if they are late, illegible, incomplete, damaged, irregular, mutilated, forged, garbled or mechanically or electronically reproduced. Unless otherwise set out herein, no communication or correspondence will be exchanged with entrants except with those selected as a potential winner.
- (d) Entries received online shall be deemed to be submitted by the authorized account holder of the e-mail address associated with the entry. 6. One (1) gift card for Le Petit Bar, located at 399 Water Street, Peterborough in the amount of one-hundred Canadian dollars (CDN \$100.00); and
7. One (1) local gift box featuring artwork, bath and body, food and drink, and lifestyle products from local entrepreneurs, artisans and small businesses in Peterborough & The Kawarthas. To be delivered to Stillwater on Lake once hotel booking is made valued at two-hundred Canadian dollars (CDN \$200.00).

13. Two-hundred (200) "Downtown" Dollars to use for shopping in Downtown Peterborough, Ontario valued at two-hundred Canadian dollars (CDN\$200.00); and
14. One (1) gift card for Couture Candy Ptbo, located at 386 George Street North in the amount of one-hundred Canadian dollars (CDN\$100.00).

(iii) **Prize #3 - BREWS & BITES** package in the form of a gift certificate including:

5. One (1) gift card for Bobcaygeon Brewing Company, located 4-649 The Parkway, Peterborough Ontario at for product tour/merchandise in the amount of fifty Canadian dollars (CDN\$50.00);
6. One (1) gift card for Belmont Lake Brewery, located at 54 Fire Route 17, Havelock Ontario for product tour/merchandise in the amount of fifty Canadian dollars (CDN\$50.00);

7. One (1) gift card for Black's Distillery, located at 99 Hunter Street East, Peterborough Ontario for product tour/merchandise in the amount of fifty Canadian dollars (CDN\$50.00);
 8. One (1) gift card for Kawartha Country Wines, located at 2452 Peterborough County Road 36, Buckhorn Ontario for product tour/merchandise in the amount of fifty Canadian dollars (CDN\$50.00);
 9. One (1) gift card for Rolling Grape Vineyard, located at 260 County Road 2, Bailieboro Ontario for product tour/merchandise in the amount of one-hundred and fifty Canadian dollars (CDN\$150.00);
 10. One (1) gift card for Canoe & Paddle, located at 18 Bridge Street, Lakefield Ontario in the amount of one-hundred Canadian dollars (CDN\$100.00);
 11. One (1) gift card for Publican House Pub, located 294 Charlotte Street, Peterborough Ontario in the amount of one-hundred Canadian dollars (CDN\$100.00); and
 12. One (1) gift card for Ashburnham Ale House, located at 128 Hunter Street East, Peterborough Ontario, in the amount of one-hundred Canadian dollars (CDN\$100.00).
- (b) Each Prize has an approximate value of Two-Thousand, six hundred Canadian dollars (CDN \$2,600.00).
- (c) Winners are not entitled to monetary difference between actual Prize value and stated approximate Prize value, if any.
- (d) The Sponsors and/or the Sponsors' representatives will contact the Winners to coordinate the provision of the Prizes within three (3) business days once such Winners have been successfully contacted and notified of his/her Prize and fulfilled the requirements set out herein.

5. PRIZE CONDITIONS.

- (a) Winners must be available to participate in the Prize from June 1, 2021 through December 31, 2021. Should Winner be unable to participate on the dates and times designated by the Sponsors, the Prize will be forfeited and awarded to an alternate winner.
- (b) Winners will be responsible for all incidental costs and expenses not explicitly included in the Prize. Winners may be required to present a valid major credit card upon check-in at the hotel to cover any expenses over and above the standard room charge.
- (c) The terms by which the gift cards/gift certificates/passes may be redeemed are governed by the individual retailer or service provider. Corus is not responsible for administering or ensuring compliance with the terms and conditions relating to the gift cards/gift certificates/passes.
- (d) In the event that, due to the COVID-19 pandemic, there are government regulations in place restricting social gatherings on the dates and times designated by the Sponsors, the Sponsors will make best efforts to coordinate a rescheduled date for the trip/events with

the Winners. If the Sponsors are unable to reschedule and provide the Prize because of such regulations or related circumstances beyond their control, then the Prize shall be deemed fulfilled and will not be substituted, except in the sole discretion of the Sponsors.

- (e) Prizes must be accepted as awarded and cannot be transferred, assigned, substituted or redeemed for cash, except at the sole discretion of the Sponsors. Any unused, unclaimed or declined portion of a Prize will be forfeited, have no cash value and the Sponsors shall have no obligation to provide either an alternative or value-in-kind. The Sponsors reserve the right, in their sole discretion, to substitute a prize of equal or greater value if a Prize (or any portion thereof) cannot be awarded for any reason.
- (f) The Sponsors shall not assume any liability for lost, damaged or misdirected Prizes.
- (g) In the event that any of the businesses were to close, that portion of the Prize will become null and void and will not be replaced with another.

6. **WINNER SELECTION.**

Three (3) Winners shall be selected as follows:

- (a) On or about June 1, 2021 in Peterborough, Ontario, one (1) Nominee will be selected by a random draw from all eligible entries received during the Contest Period for each of the three (3) pools based on the prize selected at entry. **Each Nominee shall be eligible to win only one (1) Prize.** Before being declared a Winner, the selected Nominee shall be required to correctly answer, without assistance of any kind, whether mechanical or otherwise, a time-limited, mathematical skill-testing question to be administered during a pre-arranged telephone call or by e-mail, to comply with the Contest Rules and sign and return the Release (described below).
- (b) The odds of being selected as a potential winner are dependent upon the number of eligible entries received by the Sponsors.

Upon notification, the selected Nominee must respond by telephone or e-mail (as specified in the notification) to the contact number or e-mail address provided no later than the indicated deadline set out in the Contest Rules and/or the notification. If the selected Nominee does not respond accordingly, he/she will be disqualified and will not receive a Prize and another Nominee may be selected in the Sponsors' sole discretion until such time as a Nominee satisfies the terms set out herein. The Sponsors are not responsible for the failure for any reason whatsoever of a selected Nominee to receive notification or for the Sponsors to receive a selected Nominee's response.
- (d) If, as a result of an error relating to the entry process, drawing or any other aspect of the Contest, there are more selected entrants than contemplated in these Contest Rules, there will be a random draw amongst all eligible Prize claimants after the Contest's closing date to award the correct number of Prizes.

7. **RELEASE.** Winners will be required to execute a legal agreement and release ("**Release**") that

The Sponsors are not responsible for any incorrect or inaccurate information, whether caused by website users or by any of the equipment or programming associated with or utilized in the Contest or by any technical or human error which may occur in the administration of the Contest. The Sponsors assume no responsibility for any error, omission, interruption, deletion, defect, delay in operation or transmission, communications line failure, theft or destruction or unauthorized access to, or alteration of, entries. The Sponsors assume no responsibility or liability in the event that the Contest cannot be conducted as planned for any reason, including those reasons beyond the control of the Sponsors, such as infection by computer virus, bugs, tampering, unauthorized intervention, fraud, technical failures, or corruption of the administration, security, fairness, integrity or proper conduct of this Contest and/or the Contest Website.
- 10. CONDUCT.** By participating in the Contest, each entrant and Nominee is deemed to have executed and agrees to be bound by the Contest Rules, which will be posted at the Contest Websites throughout the Contest Period. Each entrant and Nominee further agree to be bound by the decisions of the Sponsors shall be final and binding in all respects. 13. TERMINATION. The Sponsors reserve the right, in their sole discretion, to terminate the Contest, in whole or in part, and/or modify, amend or suspend the Contest, and/or the Contest Rules in any way, at any time, for any reason without prior notice.

14. LAW. These are the official Contest Rules. The Contest is subject to applicable federal, provincial and municipal laws and regulations. The Contest Rules are subject to change without notice in order to comply with any applicable federal, provincial and municipal laws or the policy of any other entity having jurisdiction over the Sponsors. All issues and questions concerning the construction, validity, interpretation and enforceability of the Contest Rules or the rights and obligations as between the entrant and the Sponsors in connection with the Contest shall be governed by and construed in accordance with the laws of the province of Ontario without giving effect to any choice of law or conflict of law rules or provisions that would cause the application of any other jurisdiction’s laws.

15. DISCREPANCY. In the event of any discrepancy or inconsistency between the terms and conditions of the Contest Rules and disclosures or other statements contained in any Contest-related materials, including but not limited to the Contest entry form, or point of sale, television, print or online advertising, the terms and conditions of the Contest Rules shall prevail, govern and

control.

16. **SOCIAL MEDIA.** This Contest is in no way sponsored, endorsed or administered by any social media platforms on which the Contest may have been promoted and/or publicized, including but not limited to Facebook and/or Twitter. Any personal information provided in connection with the Contest is being provided to Corus and any questions, comments or complaints regarding the Contest must be directed to Corus.
