

100.5 FRESH RADIO PICK YOUR PRESENT – NAUGHTY OR NICE RULES

THE FRESH - PICK YOUR PRESENT “NAUGHTY OR NICE” CONTEST (THE “**CONTEST**”) IS INTENDED TO BE CONDUCTED IN THE PROVINCE OF ONTARIO ONLY AND SHALL BE CONSTRUED AND EVALUATED ACCORDING TO APPLICABLE CANADIAN LAW. NO PURCHASE IS NECESSARY. PARTICIPANTS MUST BE OF THE AGE OF MAJORITY IN THE PROVINCE OF ONTARIO OR OLDER AT THE TIME OF ENTRY. VOID IN WHOLE OR IN PART WHERE PROHIBITED BY LAW. ENTRY IN THIS CONTEST CONSTITUTES ACCEPTANCE OF THESE CONTEST RULES (THE “**CONTEST RULES**”).

1. ELIGIBILITY. To be eligible for this Contest, an individual must:

- (a) be a legal resident of the Province of Ontario;
- (b) be of the age of majority or older at the time of entry; and
- (c) be able to accept the Prize as awarded.

2. CONTEST PERIOD. The Contest begins at 8:00 a.m. Eastern Time (“**ET**”) on November 29, 2021 and ends at 8:20 a.m. ET on December 10, 2021 (the “**Contest Period**”) after which time the Contest will be closed and no other entries shall be accepted.

3. HOW TO ENTER.

- (a) There is no purchase necessary to enter the Contest. Enter using the method of entry outlined below. No entries will be accepted by any other means.
 - i. Listen to the Station Monday to Friday at approximately 8:00 a.m. ET (“**Contest Occasion**”) for the “pick your present” cue to be announced (the “**Cue to Text**”). Upon hearing the Cue to Text, listeners are invited to text the entrant’s name and correct Cue to Text password to (705) 876-1005 (the “**Contest Line**”). After five (5) minutes from the Contest Occasion, two (2) random text entries, as selected by the on-air host, will be contacted to play the Contest game. The Station will contact the selected entrants at the phone number used to submit the text. If the Station is unable to reach either of the

selected entrants or the call back goes to voicemail (whichever comes first), another eligible entrant(s) will be randomly selected at the sole discretion of the Station.

The second selected entrant who is able to answer the Station's call will qualify to win one (1) of the remaining twenty (20) numbered "Christmas presents". Each "Christmas present" will reveal the description of a Prize (as defined below). The first selected entrant will then have the opportunity to be "naughty and steal" the second entrant's present or pick their own present. If the first entrant "steals" the second entrant's present, the second entrant picks again. Each contestant will qualify to win the Prize revealed inside the "Christmas present" chosen. **There will be one (1) Cue to Text per weekday.**

- (b) Limit of one (1) entry per Cue To Text. Any contestant who wins a Prize may not participate in any further Cues to Text during the Contest Period.

- (d) Streaming listeners may be listening to a delayed stream of the radio signal, which may vary depending on the device on which you are listening and the speed of the internet connection. Sponsors recommend turning on a radio to the Station for the Cue to Text. Sponsors assume no liability for entrants not making timely texts to the Station due to delays in the streamed signal.
- (e) If the telephone connection between the Station announcer and an entrant is not clear, such that the announcer and/or entrant cannot hear each other or the entrant is disconnected, that entrant may, in the sole discretion of the Sponsors, be disqualified and the Releasees (defined below) will not be liable in any way.
